#### **FUNDING DECISIONS**

The Board of Trustees makes all grant decisions. Applicants will be officially notified of the scholarship outcome by letter, after finalists' interviews have concluded.

Scholarships shall be awarded one time per year, during the fall semester of each year. The investment market will determine the number and the amount of the scholarship award, but individual scholarships shall be no less than \$5,000.

Scholarships will be paid directly to the law school.

Junior year law school scholarship recipients will not be precluded from applying for funds their senior year. However, priority will be given to new applicants.
