HOW DO I ENTER?

The contest is open to students in grades 6-12 in Genesee County. Photographs from any type of camera will be accepted. Photographs should be no larger than 8 1/2" x 11". No purchase or payment is necessary to enter or win the contest.

Submit photograph with the completed entry form and release forms. Photographs must be postmarked no later than February 29, 2008. Only one entry per student is allowed. A written label must be attached to the back of the photo with your name, title of photo, signature, and parent's or guardian's signature if you are under 18. Digital /or electronically transmitted photos will NOT be accepted.

HOW ARE THE PHOTOS JUDGED?

Members of the Genesee County Bar Association Law Day Committee narrows the entries to the top ten in each grade. Members of the Bar Association then vote for the winning entries at our March 17, 2008, Monthly Membership Meeting. **Photographs selected will be based upon creativity, expressiveness, originality, and quality which depict IMAGES OF FREEDOM.** Winners will be notified by March 31, 2008 and will receive a \$25 gift certificate. All entries will receive a certification of participation.
