HOW ARE THE PHOTOS JUDGED?

Members of the Genesee County Bar Association Law Day Committee narrows the entries to the top ten in each grade. Members of the Bar Association then vote for the winning entries at our March 17, 2008, Monthly Membership Meeting. Photographs selected will be based upon creativity, expressiveness, originality, and quality which depict IMAGES OF FREEDOM. Winners will be notified by March 31, 2008 and will receive a \$25 gift certificate. All entries will receive a certification of participation.
