TYPE OF CASE:

Criminal prosecution. The People of the State of Michigan charged Adrian Forrester with Armed Robbery, Assault with a Dangerous Weapon, and aiding and abetting.

Defendant Adrian Forrester claims that it was not Adrian Forrester's intent to commit any assault with a dangerous weapon or to rob Morgan Gordon.

The case will be tried before a jury in Genesee County Circuit Court.

NATURE OF LEGAL CLAIMS:

The prosecution claims that defendant Adrian Forrester along with Riley Blackmore entered into the home of Morgan Gordon without permission, robbed Morgan Gordon by knife point, and assaulted Hunter Gordon with a knife. Defendant Adrian Forrester claims that Riley Blackmore acted alone and Adrian Forrester did not know what was going on.

SUMMARY OF FACTS:

Defendant Adrian Forrester is friends with Morgan Gordon, Riley Blackmore, and Drew Gonzales. In the Summer of 2008, Defendant Forrester entered into Morgan Gordon's home with Riley Blackmore. While at the premises, Adrian Forrester who had a knife grabbed Hunter Gordon and refused to let Hunter go. While Adrian was holding Hunter, Riley Blackmore assaulted Morgan Gordon and searched for money in the home. After the money was found, Adrian let Hunter go and gave the knife back to Riley. As Hunter was calling the police, Riley stabbed Hunter in the left side then locked Morgan in a closet.

During the investigation, Det. Corey Probert found an email between Morgan and Adrian in which Morgan described a murder for hire situation then complained about Hunter. Adrian stated that they could help resolve the problem. Further, Riley Blackmore sent Adrian Forrester a text message shortly before entering Morgan Gordon's home stating "Let's get Hunter."

STIPULATIONS

1. The elements of Armed Robbery are as follows:

- a. The defendant used force or violence against the victim.
- b. The defendant did so while he/she was in the course of committing a larceny. A “larceny” is the taking and movement of someone else’s property or money with the intent to take it away from the person permanently.
“In the course of committing a larceny” includes acts that occur in an attempt to commit the larceny, or during the commission of the larceny, or in the flight or attempted flight after the commission of a larceny, or in an attempt to retain possession of the property or money.
- c. The victim was present while defendant was in the course of committing the larceny
- d. That while in the course of committing the larceny, the defendant possessed a weapon designed to be dangerous and capable of causing death or serious injury.

See CJI2d 18.1; *See also* *People v Turner*, 213 Mich App 556; 540 NW2d 728 (1995).

2. The elements of Assault with a Dangerous Weapon are as follows:

- a. The defendant either attempted to commit a battery on the victim or did an act that would cause a reasonable person to fear or apprehend an immediate battery. A battery is forceful or violent touching of the person or something closely connected to that person.
- b. The defendant intended either to injure the victim or to make the victim reasonably fear an immediate battery.

- c. That at the time, the defendant had the ability to commit a battery, appeared to have the ability, or thought he/she had the ability.
- d. That the defendant committed the assault with a dangerous weapon.

See CJI2nd 17.9.

3. A dangerous weapon is defined as any object that is used in a way that is likely to cause serious physical injury or death. CJI2nd 17.10(1).

4. The elements of Aiding and Abetting are as follows:

- a. the crime charged was committed by the defendant or some other person;
- b. that before or during the crime, the defendant did something to assist in the commission of the crime; and
- c. the defendant intended the commission of the crime or had knowledge that the principal intended its commission at the time he gave aid and encouragement.

See CJI2nd 8.1; *See also* *People v Turner*, 213 Mich App 556; 540 NW2d 728 (1995).

5. Even if the Defendant knew that the alleged crime was planned or was being committed, the mere fact that he/she was present when it was committed is not enough to prove that he/she assisted in committing the underlying crime. *See* CJI2d8.5

6. Defendant Adrian Forrester is charged with the Armed Robbery, Assault with a Dangerous Weapon, and Aiding and Abetting.

7. Armed Robbery and Assault with a Dangerous Weapon are felonies punishable by imprisonment in the state prison for life, or for any term of years.

8. Every person who directly commits the act constituting an offense or procures, counsels, aids, or abets in its commission shall be punished as if he had directly committed such offense. *See* MCLA 767.39.

9. The defense argues that Defendant did not intend for the actions to occur.

10. Riley Blackmore was charged with Armed Robbery and Assault with a Dangerous Weapon.

11. Blackmore pled guilty to Assault with a Danger Weapon. The charges for Armed Robbery and Assault with Intent to Commit Great Bodily Harm were dismissed. Sentencing has yet to occur.

12. The presiding judge will conduct the trial according to the Michigan Rules of Evidence. Trial will be by jury.

13. The jury will be instructed on the elements of the offense according to the jury instructions.

14. The presiding judge will entertain no motions other than for an order sequestering the witnesses. Such a motion should be made after the introduction of counsel and before the plaintiff's opening statement.

15. All exhibits included in these case materials are authentic and are accurate in all respects; no objections to the authenticity of the exhibits will be entertained.

STATEMENT OF MORGAN GORDON

AFFIDAVIT OF MORGAN GORDON

Plaintiff Witness

1. My name is Morgan Gordon. I am a sophomore at Flint Community Public High School. I am sixteen (16) years old. I live at 4569 Cooper, Flint, Michigan. My email address is mgordon@bemail.com. My cell phone number is 810-555-4344.
2. In school, I hang around my friends, Adrian Forrester, Riley Blackmore, and Drew Gonzales. Adrian and Riley are seniors at Flint Community Public High School. Drew is a junior.
3. On or about August 5, 2008 between 12:00 p.m. and 5:30 p.m., I was at home babysitting my sibling, Hunter, who is ten (10) years old while my parents were at work. I was not allowed to let anyone into the house while my parents were gone. If I did, then I would be grounded again.
4. At approximately 3:15 p.m., Adrian and Riley came over to the house.
5. Adrian and Riley came over to my house in a Red Pontiac Sunfire which was driven by Drew. Drew stayed in the car.
6. Adrian knocked on the front door; while Riley stood behind Adrian. I answered the door by only opening it a few inches. I told Adrian that I could not have visitors but Riley pushed the door open with force that the door hit me in the face.
7. When Riley walked into the house, Riley pushed me into the dining room. When we were in the dining room, Riley punched me in the cheek and I screamed.
8. After I screamed, Hunter came out and stated that we could not have visitors in the house while our parents were gone.
9. Adrian told Hunter to leave us alone and go play. Before Hunter left, Adrian grabbed Hunter's arm and told Hunter not to say anything about Adrian and Riley being in the house. Adrian pushed Hunter towards the hallway.
10. After Hunter left, Riley pulled a knife out of Riley's back pant's pocket. Riley handed the knife to Adrian who took it.
11. Riley came over to me and grabbed me by the arms. I told Riley to leave me alone and get out of the house. I pleaded with Riley to leave me alone but Riley refused. Riley asked me where the money that I owed Drew was located. I asked Riley, "what money? I don't owe Drew any money."
12. Adrian told me that "you took Drew's money from the table at lunch yesterday."

13. I told Adrian that I did not take Drew's money. It was my money that I had left over from paying for lunch. Adrian came closer and grabbed Riley's arm. Adrian still had the knife. I was afraid that I was going to get hurt. I called for Hunter to call the police. Riley punched me in the jaw and I fell onto the floor.
14. I am approximately 5'6", 125 pounds. Adrian is 5'8" and approximately 160 pounds. Riley is 6'0" and approximately 350 pounds.
15. Hunter came out of the hallway and Adrian grabbed Hunter.
16. Riley began to search the living room. Riley found money in the drawer of the hutch in the dining room. When Riley found the money, he yelled to Adrian that there was about two hundred (\$200) dollars in cash in the drawer.
17. Adrian let go of Hunter. Riley went up to Adrian and told Adrian to get into the car.
18. When Adrian let go of Hunter, Hunter ran to the telephone.
19. I was in fear of my and Hunter's lives especially when Adrian turned over the knife to Riley.
20. When Adrian gave the knife to Riley, Adrian said something that I could not hear and was moving towards the front door to leave.
21. Riley saw Hunter pick up the telephone and Riley ran over to Hunter.
22. Hunter was able to dial 911 when Riley jumped at Hunter and stabbed Hunter with the knife. Hunter screamed and dropped the telephone. I was fearful that Hunter was killed, all because of \$200.
23. I went to help Hunter when Adrian grabbed my arm and told me to stop.
24. Riley came over to me and grabbed my arm. Riley led me to a closet. Riley opened the door and put me into the closet. Riley still had the knife. Once Riley closed the door, I heard something placed against the closet. I tried to open the door but was unable to do so.
25. I heard Riley tell Adrian to get in the car. I heard the front door open and close. I was left in the closet until the police arrived and let me out.
26. Hunter was taken to the hospital. He/she was stabbed in the right side.
27. I cannot believe that Riley and Adrian would try and steal money at knife point. They were my friends.

28. A few days prior to this incident, I sent an email to Adrian about a story that I just saw on television. It was not my intention for Riley and Adrian to do anything to Hunter. I love Hunter. Hunter is a pain in the butt at times, gets me into trouble with my parents because of Hunter telling on me, but I would never try to hurt Hunter.

29. I did not know that Adrian, Riley, and Drew were coming over. I was not allowed to use my cell phone because I was grounded after Hunter told on me again. I did not receive any text messages from Riley on the date of this incident.

STATEMENT OF HUNTER GORDON

AFFIDAVIT OF HUNTER GORDON

Plaintiff Witness

1. My name is Hunter Gordon. I am ten (10) years old and I am a sixth grader at Flint Elementary School.
2. On August 5, 2008, my sibling, Morgan Gordon, and I were home. My parents were working and Morgan was watching me. My parents tell us that we are not allowed to have anyone in the house while they are gone.
3. I was in my bedroom when I heard voices in the living room. I went out to the living room and Morgan's friends, Adrian Forrester and Riley Blackmore, were over. I told them that they could not be in the house because mommy and daddy did not want people over while they were gone. If they stayed, then Morgan would get into trouble again. Morgan was already grounded because Morgan was smoking pot.
4. Adrian grabbed my arm and told me to go into my bedroom. Adrian said not to come out until they left. As I turned to walk to my room, Adrian winked at me.
5. Adrian and Morgan were good friends and Adrian has been over before.
6. The last time that Adrian was over to the house when my parents were at work, I told my parents about it. Morgan got into so much trouble. Morgan was grounded and not allowed to use the computer, television, or cell phone for three weeks. Morgan could not go out either.
7. Around 3:25 p.m., I heard Morgan scream. I went out to the living room to see what was going on and I saw Riley standing over Morgan and Morgan was rubbing the left side of Morgan's face. Riley is a big person. Riley towers over Morgan and has about 200 pounds on Morgan.
8. As I was walking out, Adrian grabbed me and pulled me against Adrian's body. I tried to wiggle free but Adrian had a firm hold around my waist. Adrian told me not to worry they were leaving soon.
9. I asked Adrian to let me go, but Adrian would not. Adrian had a knife in the left hand. Adrian's right arm was around my waist. Adrian never put the knife near me but I knew that Adrian had it. I made sure I did what Adrian wanted.
10. As Adrian held me around the waist, Riley began searching the hutch in our dining room. Riley found something because Riley said that there was about two hundred like Morgan said. Riley stuffed it into the left pocket of Riley's jeans.

11. Adrian let me go and walked over to Riley asking Riley to leave. I ran for the telephone.
12. As I dialed 911, Riley came at me with the knife. I heard the dispatcher ask what the emergency was. I screamed, "Riley has a knife." As I said it, Riley stabbed me in the right side of my stomach. I screamed.
13. I fell to the ground. Morgan began to come over and Riley grabbed Morgan then put Morgan in the closet. I picked up the phone and told the dispatcher that Riley Blackmore stabbed me in the stomach.
14. Riley put a chair under the closet door knob.
15. Adrian and Riley left. I heard the car peel out. About 10 minutes later, the police came with an ambulance. I was taken to the hospital, where I received 25 stitches.

REPORT OF DETECTIVE COREY PROBERT

AFFIDAVIT OF DETECTIVE COREY PROBERT

Plaintiff's Witness

1. My name is Corey Probert. I am employed at the Flint Police Department as a detective. I have been an officer since 1990 and a detective since 2003. As part of my job duties, I investigate violent crimes such as armed robbery, felonious assault, domestic violence, and homicide.
2. On or about August 5, 2008, I was working first shift which is 0730 hours until 1630 hours. At approximately 1545 hours, I heard a radio call of armed robbery in progress and possible assault with a dangerous weapon at 4569 Cooper, Flint, Michigan. The dispatch stated that one of the occupants may have been stabbed and an ambulance was also directed to the house. Since I was in the area, I decided to assist.
3. I arrived at the location at 1553 hours, the front door to the house was opened but there was a screen door that was closed. I drew my weapon and knocked on the door. I yelled out that I was with the Flint Police Department. I heard a low sounding voice say, "in here." I entered with my weapon drawn and found a young child on the floor bleeding and unconscious. I yelled out asking whether anyone else was here. I heard banging on the closet door.
4. Other officers arrived to check the interior of the premises. I found a chair lodged under the door knob of a closet where I heard someone yelling and pounding on the door. I removed the chair from under the door knob and opened the door. A teenager was in the closet. I asked for a name. The occupant stated "Morgan Gordon." The ambulance arrived to assist the young child. They were able to revive the child. The paramedics loaded the child to the hospital.
5. I talked with Morgan Gordon who stated that the young child was Hunter Gordon. I asked what happened. Morgan advised that Adrian Forrester and Riley Blackmore came over to the house with Drew Gonzales in a Red Pontiac Sunfire. Blackmore and Forrester came to the door and were told that they could not enter. Suspect Blackmore forced entry into the house, causing the door to hit Morgan in the face leaving a red mark. Suspect Blackmore then handed Suspect Forrester a knife. Suspect Blackmore then punched Morgan in the face. Forrester grabbed Hunter around the waist while Riley searched the hutch for money which Riley found approximately \$200. After finding the money, Suspect Forrester let Hunter go and handed the knife back to Blackmore. As Hunter began to call for assistance, Suspect Blackmore stabbed Hunter in the right side of the stomach. Suspects then left in the vehicle driven by Gonzales.
6. I went to the hospital with Victim Hunter Gordon. Hunter Gordon received approximately 25 stitches in the right side. Hunter was admitted to the hospital for observation.

7. I searched for the Red Pontiac Sunfire driven by Drew Gonzales.
8. At approximately 1706 hours, I located the Red Pontiac Sunfire at Adrian Forrester's house located at 349 W. Fifth Street, Flint, Michigan. A woman answered the door, I identified myself, and asked to speak with Adrian Forrester. I was allowed into the house by Annette Forrester, Adrian's mother. I found Forrester in the upper east side bedroom with Drew Gonzales. Adrian Forrester appeared to be distraught as Adrian was crying and rocking back and forth. Blackmore came into the room after I arrived. I identified myself and advised them I was there due to an incident at 4569 Cooper, Flint, Michigan that occurred at approximately 1530 hours this afternoon.
9. I placed the three suspects in handcuffs while I further investigated the room. The computer was on and there was an email from mGordon@bemail.com to killerdog@bemail.com. In the email, it mentioned a case where a lady had an affair with a guy who lived out of state. They met and discussed the lady's estranged husband and the divorce. The two had an affair and the police were saying the lady asked the guy to kill her husband before the divorce trial because the lady would receive more assets if she died as his wife rather than his ex-wife. The guy killed the estranged husband. The couple stood trial but the lady got off because she claimed that someone broke into the house that she shared with her estranged husband, knocked her out, and killed her husband. The jury believed it. The email further stated that Hunter was annoying and got Morgan into trouble. Wish something could quiet him/her down...but \$200 won't do it.... Then it stated LOL. Adrian responded stating that would be his/her luck. I printed the email.
10. I went into the bathroom where I thought Blackmore was at when I first came to the house. In the sink, I found a knife. I took the knife and logged it into evidence.
11. After talking with Riley Blackmore, I tried to find a text message from him/her to Morgan Gordon but was unable to locate any such text. I did find a text message from Riley Blackmore to Adrian Forrester.

STATEMENT OF ADRIAN FORRESTER

AFFIDAVIT OF ADRIAN FORRESTER

Defense Witness

1. My name is Adrian Forrester. I am a senior at Flint Community Public High School. I am seventeen (17) years old. I am approximately 180 pounds and 5'9" tall. My email address is killerdog@bemail.com. My cell phone number is 810-555-4434.
2. Normally, I hang around my friends, Morgan Gordon, Drew Gonzales, and Riley Blackmore. Drew drives a Red Pontiac Sunfire. Drew usually drives us around as Drew is the only one with a car.
3. On or about August 1, 2008, I received an email from Morgan about a lady who had someone kill her husband. Then, he/she talked about hurting Hunter and being an only child. I did not take it seriously because it was what I thought was normal sibling rivalry like my older brother and me. When I said that we could resolve something, I meant that we could talk to Hunter about what Hunter was doing. I never would have physically hurt Hunter, maybe scare Hunter but not hurt Hunter.
4. On or about August 5, 2008, I was hanging out with Drew and Riley. We decided to go and check on Morgan. Drew was hesitant because he/she and Morgan got into an argument regarding money that Morgan owed Drew. I don't know what it is about but Drew did not want to go into the house.
5. Riley and I walked up to the front door of the house. I knocked on the door. Morgan opened the door and let us in. We were talking and laughing when Hunter came out of the hallway. I grabbed Hunter and told Hunter to leave us alone, you caused enough trouble before. Hunter went back down the hallway and entered a bedroom.
6. Riley gave me a knife that belonged to Riley's grandfather. We were talking about how old the knife was when Morgan said to hit the left cheek. Morgan walked into the dining room and Riley followed. Morgan told Riley that the money was in the hutch drawer. Riley hit Morgan in the face and Morgan screamed. I still had the knife in my left hand.
7. Hunter came out and I grabbed Hunter. I never put the knife anywhere near Hunter. I only grabbed Hunter to protect Hunter. I did not know what was going on between Morgan and Riley. Riley began searching through the hutch and then said that "here's \$200." I let Hunter go, gave the knife back to Riley, and I began to leave the room.
8. Hunter ran towards the phone. I turned around once I got to the front door and saw that Riley jumped near Hunter and made a stabbing motion. Hunter

screamed and fell to the ground. I was stunned and did not move. Riley put Morgan in the closet and put a chair under the door knob. I thought I heard Morgan laugh.

9. Riley told me to get in the car. I got into Drew's car and Riley said that they got the money, stabbed Hunter, and needed to leave. Drew spun the wheels and went back to my house.

10. I cannot believe this happened. I had nothing to do with it.

STATEMENT OF DREW GONZALES

AFFIDAVIT OF DREW GONZALES

Defense Witness

1. I am Drew Gonzales. I am a junior in Flint Community Public High School where I attend with Morgan Gordon, Riley Blackmore, and Adrian Forrester. I have been friends with Adrian Forrester since kindergarten.
2. I drive a red Pontiac Sunfire. My parents bought me the car when I got my driver's license.
3. Morgan hates his/her sibling, Hunter. Hunter is always causing trouble and telling on Morgan. One time, I went over Morgan's house. We went out back and were smoking a cigarette. Hunter caught us and told on Morgan. Morgan was grounded for a month and was not allowed to hang out with me any longer. Morgan was tired of Hunter getting in Morgan's business then telling on Morgan to their parents.
4. Morgan wanted to scare Hunter and Morgan asked Adrian and me to help in scaring Hunter by threatening Hunter with physical harm. I did not want to do it because I got into enough trouble with the cigarette incident. I did not want to get into any more because I would lose my ride. Adrian laughed at Morgan's request.
5. On August 5, 2008, I drove Adrian and Riley to Morgan's house at approximately 3:20 p.m. I stayed in the car because Morgan and I got into a fight a couple of days earlier. I saw Morgan and Riley enter the house.
6. Approximately 3:40 p.m., Riley and Adrian came out of the house. Riley was laughing and then took \$200 out of the left pocket. He said that Morgan came through as they agreed.
7. Adrian began crying and became sick. I had to stop the car several times because Adrian had to throw up.
8. We went to Adrian's house after we left Morgan's house. Adrian did not stop crying. When we got to Adrian's room, Riley showed me the knife which appeared to have some blood on it. Riley went into the bathroom to wash the knife off.
9. About an hour later, a police detective came into Adrian's room and arrested us all. I did not know what was going on. My parents came and picked me up at the police department. Thanks to this crap, I lost my car.

STATEMENT OF RILEY BLACKMORE

AFFIDAVIT OF RILEY BLACKMORE

Defense Witness

1. My name is Riley Blackmore. I am a senior at Flint Community Public High School. I am friends with Morgan Gordon, Adrian Forrester, and Drew Gonzales.
2. On August 5, 2008, Adrian, Drew and I were at Adrian's house. Before we went driving around in Drew's car, Adrian showed us an email that Morgan sent. In the email, Morgan told Adrian about a lady who got a lover to kill her husband. She beat the rap by the lover hitting her and putting her in the closet. Then Morgan complained about Hunter again and wanting to teach Hunter a lesson. I suggested we help.
3. As we were driving, I sent a text message to Morgan that stated we were coming over, we will help scare Hunter, and not to worry, we got your back with your parents. I typed the telephone number into the cell phone. Morgan did not reply.
4. Drew drove over to Morgan's house. Adrian and I got out and went to the door. Morgan opened the door. We walked into the house. We began laughing about something when we heard Hunter come down of the hallway. Morgan said to hit the left cheek as if we were fighting. Before I did, I gave my knife to Adrian to hold. As Hunter came out of the hallway, Adrian grabbed Hunter and told Hunter to leave us alone. Hunter left the room.
5. Morgan and I walked into the dining room.
6. I told Morgan to turn around and let's scare Hunter. I asked if Morgan was ready then I hit Morgan in the cheek. Morgan fell to the ground and screamed. Adrian yelled at me. I told Adrian to shut up. Hunter came out of the back bedroom.
7. Adrian grabbed Hunter. Morgan and I faked an argument and Morgan whispered that there was money in the hutch. I went into the hutch and found \$200 dollars. I told Adrian that I got the \$200. Adrian let go of Hunter, gave my knife to me, then Adrian began to walk out of the house as Hunter went for the telephone.
8. I heard Hunter state that Riley Blackmore and Adrian Forrester are in the house and have a knife. They stole \$200. I ran for Hunter with the knife in my hand. As I went to grab for Hunter, I stumbled and accidentally stabbed Hunter in the side. Hunter fell to the ground. Morgan smiled. I looked at Morgan then grabbed Morgan by the arm. I led Morgan to the closet and told Morgan that I did not want their parents to blame Morgan. I locked Morgan in the closet.

9. Adrian and I left the house. Adrian was crying and shaking. I took out the money and put it on the dashboard telling Drew that we helped Morgan but I stabbed Hunter. We drove to Adrian's house to figure out what to do.
10. When we got to Adrian's house, Adrian could not stop crying. Adrian sat in a chair in the corner of the room. Drew and I tried to calm Adrian down but we couldn't. I went into the bathroom to wash off the knife. When I came back into the room, the police officer was there.
11. I pled guilty to Assault with a Dangerous Weapon and am awaiting sentencing. I was tried as an adult. I previously was in juvenile detention and would hate for anyone, especially one of my friends, to have to go through that or what I am going through. I accept what I did was wrong and am really sorry. I do not want anyone to go through this with me.
