Your voice was heard and I hope you are able to find it reflected in the five priority focus areas identified in the Strategic Planning Committee's **2012 STRATEGIC PLAN-NING REPORT AND RECOMMENDATION** and within the innovative initiatives that over the next few years will be created to implement our goals. ## PROPOSED GCBA BYLAWS AMENDMENTS

[**Background:** On Friday, February 17, 2012, members of the Strategic Planning Committee met and recommended five priority focus areas, including an amendment to the GCBA by-laws to allow for an Affiliate Membership category. On Thursday, March 15, 2012, at a regularly scheduled board meeting the Board of Directors adopted the 2012 Strategic Planning Report and Recommendations and approved the following by-laws Amendment language allowing for an Affiliate Membership, thereby moving it forward for a vote by the general membership, in accordance with the bylaws.]

## The <u>VOTE</u> on the following proposed GCBA by-law amendments shall take place at a Special Meeting called for: <u>MONDAY, APRIL 16, 2012, AT 12</u> <u>NOON</u>, preceding the regularly scheduled monthly meeting on Monday, April 16, 2012, at the Masonic Temple.

## **AMENDMENTS:**

## ARTICLE II MEMBERSHIP AND DUES

Section 1.

D. Any person employed in Genesee County as a legal professional including, but not limited to, paralegals, legal secretaries, judicial secretaries, court clerks, court administrators, court reporters, legal support staff or persons retired from such positions, may be an Affiliate Member of the Genesee County Bar Association for an annual fee as established by the Board of Directors, notwithstanding Section 3 below. Affiliate members shall not be eligible to vote nor to serve on the Board of Directors of the Association and shall not be eligible for the various insurance plans available to attorney members. Affiliate Members shall be entitled to receive Association mailings, attend all Association functions, and otherwise enjoy all privileges of membership except those specifically restricted to attorney members. Affiliate Members may serve on any committee or sub-committee but may not be a chairperson of a lawyer practice area committee. However, an Affiliate Member is not prohibited from serving as a chairperson of an Affiliate Member professional development/ practice committee.

Section 3.

BEST works with nonprofits to build nonprofit management, development and leadership capacity through assessments, workshops and capacity building grants. One assessment tool, the Legal Compliance Review, has been facilitated by pro bono attorneys to identify risk management and compliance issues. BEST is seeking three or four local attorneys who would be available to review issues related to organizational documents, corporate formalities, conflicts of interest, tax exemption and fundraising compliance, financial records, insurance, contracts and employment issues. The Legal Compliance Review was developed by attorneys in partnership with Michigan Community Resources, an organization that provides pro bono assistance to nonprofits around the state of Michigan.
