GCBA Senior Attorneys

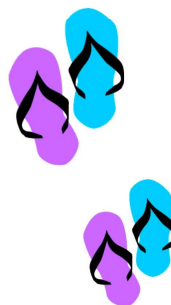




